2. Many Blue Ox® Baseplates are designed to use existing holes and hardware to mount the baseplate to the towed vehicle. Even though bolts are there, do not assume they are adequate for baseplate mounting. Always use hardware supplied in the hardware kit or existing hardware specified in the Baseplate Towing Installation Instructions.

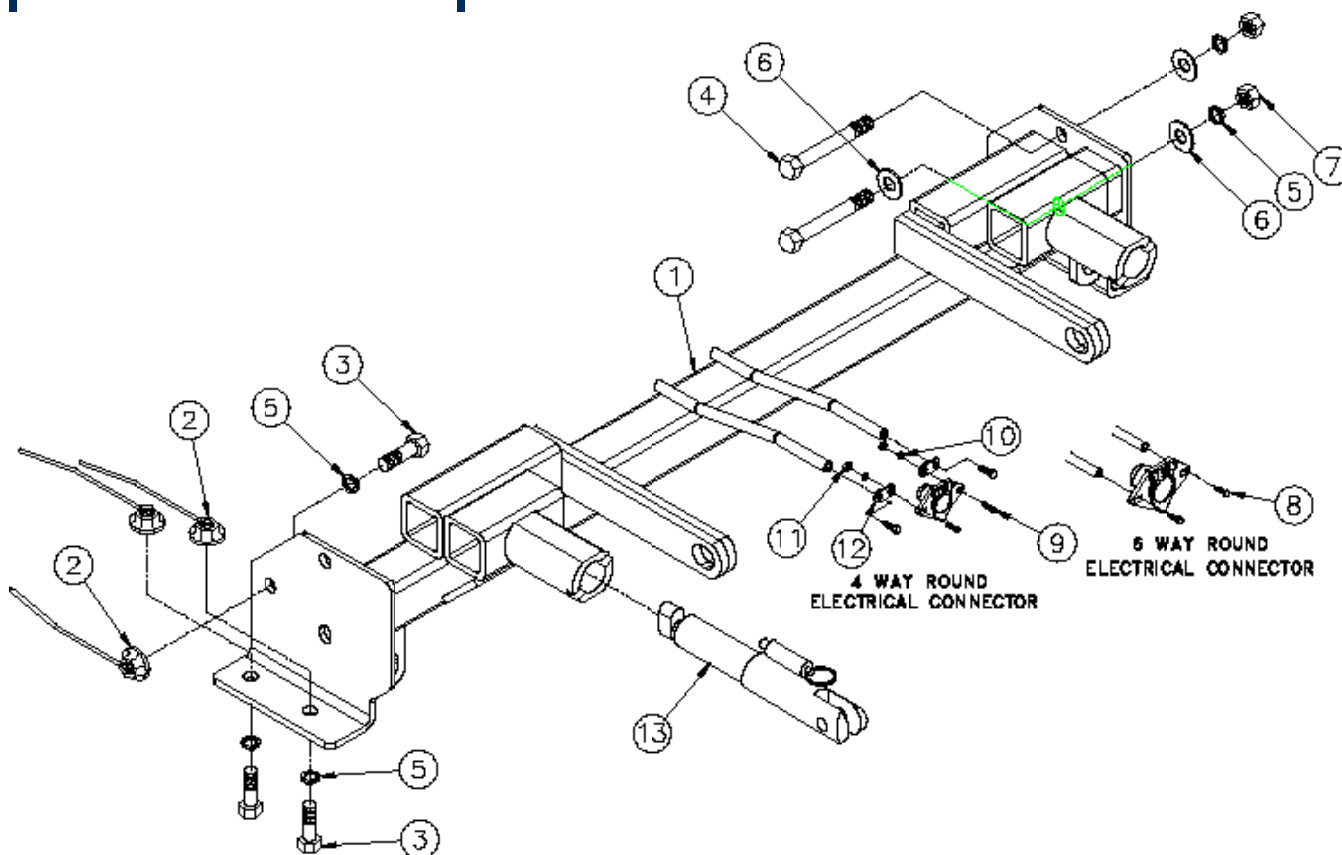

Use only genuine factory replacement parts on your baseplate. Do **NOT** substitute homemade or non-typical parts. If a bolt is lost or in need of replacement, for your safety and the preservation of your baseplate, be sure to use a replacement bolt of the same grade (In most cases it will be Grade 5, please reference the parts list above). Replacement parts may be ordered through your nearest Blue Ox® Dealer or Distributor.

### Vehicle Weight:

The weight of this vehicle is near the Class III, 5,000 lb. rating limitations. Some models, depending on options, may well exceed this 5,000 lb. rating. Be sure to confirm the weight of your individual vehicle before towing. As of 1999, the Aventa® II is now 10,000 lbs. and either the Aventa® II or the Aventa® LX tow bar must be used for these applications.

**Tow Bar Adapters are NOT to be used with vehicles weighing over 5,000 lbs.**

**Installation Notes:** The fascia and metal bumper are removed and reinstalled during installation of the baseplate. Drilling is required. Trimming of the fascia is required.

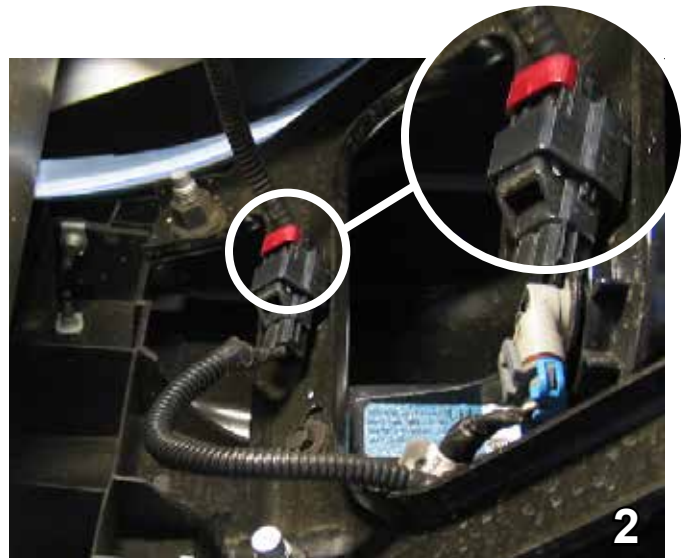
The dimensional variations between otherwise identical vehicles can be considerable. While the baseplate was designed for easy installation, it may be necessary to tailor the baseplate slightly to compensate for auto manufacturer's tolerances. These minor adjustments may include filing a hole slightly, bending electrical rods and/ or bending end plates.

The BX8869 Bulb and Socket Wiring Kit is recommended for this vehicle.

### Installation Instructions:



1. Using a T27 Torx socket remove three torx head bolts from the wheel well just forward the front tire. Do this to both sides and set push pins aside for later reinstallation.



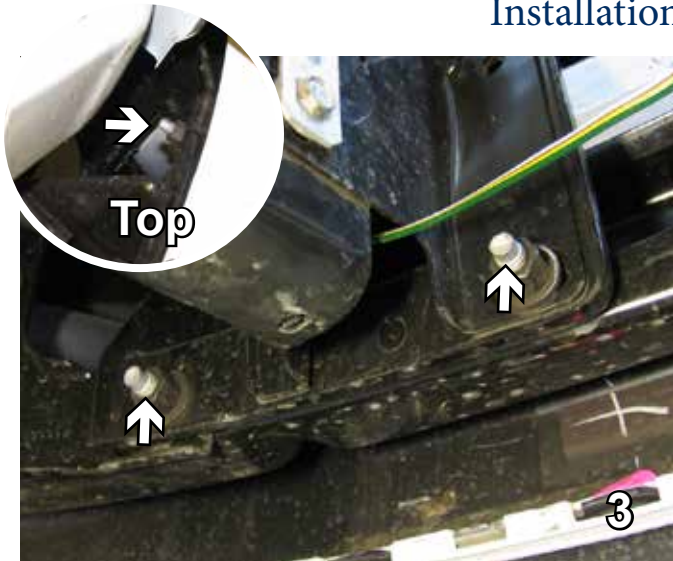
2. Located behind the pumper is a red cap on plug. Slide red cap up then push in to release plug, set plug up out of the way.

3. Using an 18MM socket, remove three bolts from behind the bumper - two on the bottom, one on the top. Do this on both sides.



4. After removing the bumper, take an 18MM socket to remove the two hex nuts and bolt plates from the bumper bracket on frame rail end. The bolt plate and hex nut will not be reinstalled. Do this to both sides.



5. NOTE: The following step require two people to complete. Doing otherwise is dangerous and can cause injury.

While holding bumper brackets in place align baseplate to the interior hole and insert 1/2-13 x 4" bolts and flat washers on both sides. before tightening, adjust bumper bracket to the previous height, then slide baseplate up to the bottom of the frame and tighten bolt and hex nuts.

**NOTE: Mark the height of bumper bracket on frame.**



6. Using the baseplate as a template, take a 17/32" drill bit and drill the bottom two holes. Do this to both sides. Install the 1/2 x 1 1/2" nut plate and lock washers into the two holes.

**BE SURE TO USE LOCTITE® RED ON ALL BOLTS BEFORE TIGHTENING. TIGHTEN ALL BOLTS ACCORDING TO THE TORQUE CHART ON THE FRONT PAGE OF THESE INSTRUCTIONS OR ON PAGE 3 OF THE BASEPLATE TOWING GENERAL INSTRUCTIONS.**

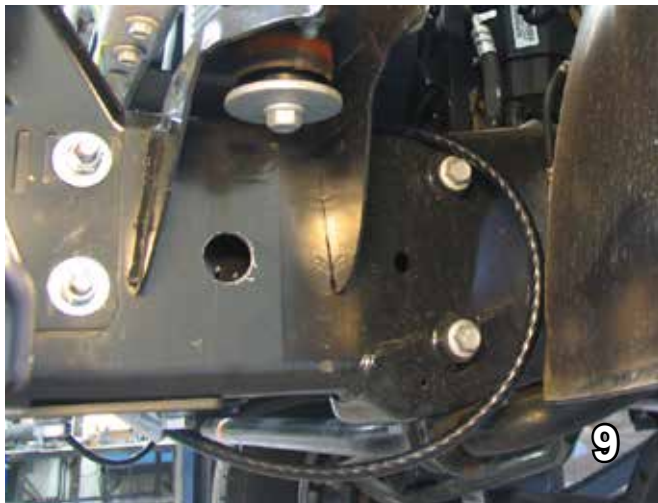


7. Drill 1 1/4" hole with a 1 1/4" hole saw in the center of the frame rail to place nut plates. After making sure bottom hex nut is tight, remove top bolt and use Loctite Red and tighten, then do the same to the bottom hex nut. Do this on both sides.



8. Using the baseplate as a template, drill with the 17/32" drill bit the back hole located on the top of the baseplate. Do this to both sides.

Be sure that **ALL** electrical connections are plugged in properly and functioning **BEFORE** installing the fascia.



9. Install the safety cables as directed, around the frame rail suspension support of the vehicle.



- 9B. Quick link the safety cables to the convenience link on baseplate. Reinstall fascia. Do this to both sides.

# General Information

1. Ensure that your product(s) are registered online at [www.blueox.com](http://www.blueox.com). It is crucial to register your product(s) so that you may be alerted of product offerings, updates, upgrades, maintenance and safety bulletins, and/or recalls.
2. **It is the owner's responsibility to inspect all towing equipment for cracked welds, missing or worn parts and loose bolts before each towing trip.** Be sure to use Loctite® Red on all bolts and tighten to the recommended specifications.
3. **It is the owner's responsibility to hook up all towing equipment per manufacturer's instructions/recommendations.**
4. Remove the attachment tabs when not in use (if applicable).

## Notice To Baseplate Installer

### 1. It is YOUR responsibility to watch for:

- Oil cooler and air conditioner lines
- Electrical wires and hoses
- Missing parts or attaching points on the frame

\*\* If the baseplate is improperly installed and is against a wire or hose, it could cause fluid leaks or electrical shorts some time after the actual baseplate installation.

## Permanent Baseplate Safety Cable Installation

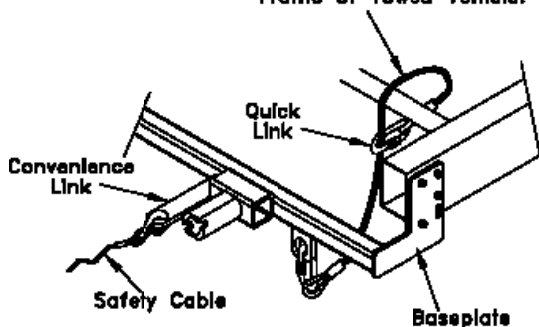
Permanent baseplate safety cables are strongly recommended when towing a vehicle with a tow bar. The principle function of the permanent baseplate safety cables is to prevent the towed vehicle from breaking loose in the event the connection between the frame of the towed vehicle and the baseplate fails or becomes disconnected. The cables must be connected from the baseplate to the frame rail or cross member of the vehicle's frame. The illustrations below show the possible arrangements recommended by Blue Ox®. Each permanent baseplate safety cable must have an adequate weight rating for the towing system. The weight rating of the two (2) cables together will not qualify.

***Do not mount the permanent baseplate safety cables against wires, hoses or brake lines.***

These permanent baseplate safety cables should remain installed as long as the baseplate is installed on the vehicle. Permanent baseplate safety cables are to be used in conjunction with, and NOT a replacement for legally required safety cables attaching the towed vehicle to the towing vehicle.
