

Towed Vehicle Charge Line Kit

Requires a minimum of 13.3 Volts to enable charge from the RV to the towed vehicle battery

This kit ensures the towed vehicle battery maintains a charge while being flat towed.

Please read and understand this manual before attempting to install the battery charger. Installation should be completed by a qualified installer. Improper installation may result in malfunction causing personal injury, property damage, or death.





Important

- All wires should be routed to avoid moving parts, hot parts, sharp parts, and fuel lines in the
 engine compartment. Wiring can be damaged by these components which can result in damage
 to the vehicle or the charger.
- This charger requires 13.3 Volts to enable charging from the RV to the tow vehicles battery. Charging will pause if the voltage from the RV drops below 13.3 volts.
- This charger requires a ground to exist between the towed vehicle and the towing vehicle.
- Only charges when the RV's engine is running. Isolated when not charging.
- Thermal protected
- Pulse with modulation (PWM) overcurrent and temperature regulation.
- · Protects from overvoltage and reverse batteries.
- Direct Current (DC) load current continuous 15 Amps.


Important:

Use only genuine factory replacement parts on your baseplate. Do **NOT** substitute homemade or non-typical parts. Replacement parts may be ordered through Blue Ox®. Failing to follow and/or altering these installation instructions in either installation or required equipment will void the manufacturer's warranty. Towing behind a non-motorized vehicle will void the warranty.

Installation Instructions:

- 1. Find a suitable mounting point for the battery charger close to the tow vehicles battery. It must be mounted within reach of the black and red "CAR" side cables with ring terminals. Use the provided wire ties or screws to securely mount the charger.
- 2. Route and secure the red "RV" side cable to the correct pin on the 6 pin connector. Avoid moving objects / hot objects / sharp objects / fuel lines. Cut the wire to the appropriate length and strip the end. Secure the wire to the 12V pin on the 6-pin connector.
- 3. Ensure the tow vehicle engine is turned off, and then remove the nut on the positive battery terminal. Attach the ring terminal from the RED wire onto the positive battery terminal and secure in place with the nut. Repeat with the Negative battery terminal and the BLACK wire.

Charger Lights:



NO LED: Charger is not receiving power from RV

Yellow Solid: 12V present from the RV. Towed vehicle battery is not charging.

Yellow & Green Flashing: 13.3V+ present from the RV. Towed vehicle battery is charging

Green: Towed vehicle battery charged.

Typical Pinout:

Blue 1) Brake Monitor Light

Black 2) Charge Line

Green 3) Right Turn / Stop

Brown 4) Tail Lights

White 5) Ground

Yellow 6) Left Turn / Stop
